APPLICATION

- Application can only be made after the applicant has successfully enrolled in Sunway University, Sunway College, Monash University Malaysia or Le Cordon Bleu.
- 2. Applications are to be made at least 30 days prior to the proposed check-in date.

FEES

- Applicants are required to pay a Non-Refundable residence application fee of MYR500 when submitting their Residence Application Form. The Management reserves the right not to process any late bookings and/or incomplete Residence Application Forms and/or where the residence application fee is not attached or if the amount is incorrect.
